"Citizens' Right to Know" Annual Report of Failures to Appear - January 1, 2024 - December 31, 2024

FS 907.043(4)(b)14a&b - No later than March 31 of every year, each pretrial release program must submit an annual report for the previous calendar year to the governing body and to the clerk of the circuit court in the county where the pretrial release program is located. The annual report must contain, but need not be limited to: 14. The name and case number of each person granted nonsecured release who: a. Failed to attend a scheduled court appearance., b. Was issued a warrant for failing to appear. Sections 14a and 14b have been combined within the annual report as a failure to appear (when a court date is mandatory) as defined in Florida Corrections Accreditation Commission mandatory standards as such "when a warrant has been issued". Many court dates do not require a defendant appear or are considered a "technical" violation due to notices of court dates not being received or when a defendant's presence is waived by the judge.
